#### **MINUTES BOARD OF FIRE COMMISSIONERS REGULAR MEETING** September 18, 2023, 7:00 p.m.

#### **CALL TO ORDER:**

Commissioner Frank called the regular meeting to order at 7:00 p.m.

**PLEDGE OF ALLEGIANCE:** Lt. Winn led the pledge.

**PUBLIC COMMENTS:** 

None received.

#### **APPROVAL OF AGENDA:**

Commissioner Frank moved to accept the agenda and move New Business 3. Volunteer Firefighters Relief & Pension Board Business to the next item to be addressed. Commissioner Bacchus seconded. The motion carried.

#### **NEW BUSINESS:**

3. Volunteer Firefighters Relief & Pension Board Business – Retired Volunteer Steve Monroe applied to the Board for Volunteer Firefighters and Reserve Officers for a retirement pension. Acting as the local board, commissioners reviewed the certification documents. Mr. Monroe served as a District volunteer from 1998 to 2013 (16 years). Commissioner Frank moved to certify Mr. Monroe's eligibility. Commissioner Kelbon seconded. The motion carried. Commissioner Frank and Secretary Rewitzer signed the Certificate of Eligibility form.

Commissioners reviewed the applications of Chloe Austin and Brady Palmer to become volunteer members. Both are wildland firefighters with the National Forest Service. Ms. Austin and Mr. Palmer both introduced themselves to the Board. Volunteer Levine

introduced himself to the Board and spoke on their behalf. Commissioner Frank moved to accept Ms. Austin and Mr. Palmer as volunteers and add them to the rolls. Commissioner Bacchus seconded. The motion carried. Commissioner Frank requested an updated list of members be distributed.

#### **APPROVAL OF MINUTES:**

Commissioners reviewed draft minutes of the August 21, 2023 Regular Meeting. Commissioner Frank moved to accept the minutes. Commissioner Kelbon seconded. The motion carried.

#### **APPROVAL OF VOUCHERS:**

Commissioner Frank reviewed individual invoices. Vouchers totaled \$97,249.29. Commissioner Frank moved to approve the vouchers. Commissioner Bacchus seconded. The motion carried. Commissioner Frank signed the Payroll and Claims check registers.

#### MONTHLY REPORTS:

- Chief's and Officer's Reports Commissioners were provided with the Monthly Fire Chiefs Report. Chief McKern reported on Quilcene Days, ESO Go Live, and a recent cardiac arrest save using the Lucas device. Commissioner Frank requested that a summary of Lucas device uses be maintained for future reference by the Board.
- Monthly Financial Report Commissioners were provided with a Treasurer's Report and a 2023 Budget Position report. Secretary Rewitzer reported August revenues included \$244,608 from timber sales. Operating expenditures are 51.3% of budget with 66.7% of the year elapsed.
- District Secretary's Report Secretary Rewitzer reported status of current activities. The auto and property insurance renewal included a 10% increase; a broker is assisting to explore options. A preliminary budget will be presented at the October meeting.
- **Commissioner's Report** No report.

#### CORRESPONDENCE:

An email was received from Elizabeth Bindschadler thanking District members for assisting the Quilcene Oyster Races on 9/17/2023.

A donation of \$1,000 was received from the Coyle Women's Club for support of the QFR CARES Program. Commissioner Frank moved to accept the donation. Commissioner Kelbon seconded. The motion carried. Secretary Rewitzer will send a thank you to the Club.

#### **UNFINISHED BUSINESS:**

- **1. Station 21 Facilities** Chief McKern reported interior painting of the Crew Quarters is nearly complete. The utility sink has been moved to Station 21.
- **2. Station 22 Facilities** Volunteer Grooms reported new signage and lighting has been installed. Public reaction to all the updates has been very favorable. The Laurel B.

Johnson Community Center will host an open house for Station 22 on September 30, 2023. This will be a recruitment and retention event and information will be provided on how emergency services are delivered on the Toandos peninsula.

- DNR Trust Lands Commissioner Kelbon reported that the Jefferson County Board of County Commissioners (BOCC) addressed state forest land issues at their September 18, 2023 meeting. Commissioner Kelbon provided comments during the meeting on the need for additional analysis and closing funding gaps.
- 4. Contracting for ALS Services Chief McKern reported on current ALS transport trends and will meet with Chief Black to address protocols for transferring patients. Nonsubstantive changes were made to the Emergency Services ILA to clarify billing and the effective date. Commissioner Frank signed the clean draft. The District 1 Board will review the ILA at their September 20, 2023 meeting.
- 5. Staff Deployments for State Mobilizations– Commissioners reviewed year-to-date information on mobilizations and expenses. Commissioner Frank requested status reports going forward.

#### **NEW BUSINESS:**

- New Policy 507: Community Assistance, Referral, and Education Services (CARES) Program – Secretary Rewitzer presented a new policy to provide guidance regarding the QFR CARES Program. Volunteer Kinser reported on current activities of the program. Commissioner Frank asked that a section on mandatory reporting be included. Secretary Rewitzer will present a revised policy at the October meeting. Commissioner Frank asked that a GPS tracking system be installed on the CARES program vehicle for member safety.
- 2. New Engine Chief McKern and Capt. McCrehin presented information about a Fouts FB94 Custom Pumper that is currently available from Cascade Fire Safety. Blythe Hirst from Cascade provided information regarding the engine. Commissioners were concerned about the cost and wanted further analysis of apparatus needs. Chief McKern will present a plan at the November meeting.

#### SEMINARS/CONFERENCES/SPECIAL EVENTS:

Commissioners are registered for the October 25, 2023 annual Laws Update Seminar from Snure Seminars via Zoom.

#### GOOD OF THE ORDER:

Volunteer D. Svetich commended Commissioner Kelbon for her comments to the Jefferson County BOCC.

#### ADJOURNMENT:

The meeting was adjourned at 8:34 p.m.



#### **Apparatus Readiness:**

- E21 has returned from NKFR. The pump issue has been resolved. The engine has been pump tested and passed. Crews have also been testing the pump to ensure that is still engaged. We have had no issues.
- The Ram Aid unit had to go to Les Schwab for an alignment and unfortunately a tire replacement; this was due to the alignment issue.

#### Training and Competency:

- Target Solutions still has 10 overdue assignments.
- Members have begun to train on the new ESO software.
- EVIP trainers have completed an EVIP Train the Trainer refresher course. There were a
  few Trainers that were unable to attend the class. I am working towards QFR hosting a
  Train the Trainer class. This would allow those members that were unable to attend the
  previous class an opportunity to refresh their certification. This would also allow us to
  certify a few new members.

#### Physical Resources and Quality of Life:

- The utility sink that was removed from the Crew Quarters has been relocated to the apparatus bay. This is a larger sink than what was previously there.
- A new Quilcene Fire Rescue sign has been purchased for both Station 21 and Station 22. Thank you to Thane Grooms for getting this done. The new sign at Station 21 will be mounted in the upper black area, just to the right of the Bob Wilson Station 21 sign.

#### QFR Events:

- September 16<sup>th</sup> is Quilcene Day. QFR will be participating in the parade as well as having E21 as a static display as well as the Safety Trailer from Brinnon Fire.
- On September 17<sup>th</sup> QFR will be assisting with the Quilcene Oyster Races. We will have both of our Aid units staffed. One will be located at Worthington Park. The other will be placed along the course. We will also have a roaming vehicle staffed with an EMT to ensure there are no injured runners along the course in between stations.

#### Significant Events and Service Delivery:

- On 08/14 we responded to a MVA on Snow Creek Rd.
- On 09/06 we responded to a motorcycle MVA on Hwy 101.

#### Training and Competency:

• Completed ESO End User training.

#### Physical Resources and Quality of Life:

- We are still doing our 60-day field testing of the Stryker Mechanical CPR Lucas Device. We are looking at extending our trial period. The Lucas Device is in service on A21 and will be deployed on CPR calls.
- ESO is almost ready for our go live date on September 18<sup>th</sup>. I just have a couple little things to finish up before Sept 18<sup>th</sup>. We have completed our End User training and on Sept 18<sup>th</sup> we will start doing all EMS and fire reports on ESO.
- With help from Capt. McCrehin and Lt. Singleton we are working on transferring all our assets from Emergency reporting to ESO. We are rebuilding the inventory system, so it is accurate going forward on ESO.
- Our QFR CARES Program is going great. Kimberly is doing a great job and has already contacted a few individuals in our district who need help. Kimberly has done a great job being a patient advocate and has gone above and beyond to help our QFR CARES contacts. Kimberly has also been getting out in the community to get the word out about our CARES Program. Kimberly will be working on training a few of our other volunteers as QFR CARES team members.
- I created an Online QFR CARES Referral form for QFR Members to use when they encounter patients who could benefit from QFR CARES visits.
- I have been attending the monthly Jeffcom user meetings to voice any questions, comments, issues, or concerns QFR has when it comes to working with our Jeffcom partners and topics regarding response and dispatch.
- Saturday Sept 16<sup>th</sup> is the Quilcene Fair and Parade
- FF/EMT Zak Torres is heading up organizing our participation in the Quilcene Fair's Parade this year.
- FF/EMT Tyson Svetich is heading up organizing our Departments Booth at the Quilcene Fair this year.
- On Sept 16<sup>th</sup> there is also a 50k and 25k marathon called Mountain Peaks Racing.
- On September 17<sup>th</sup> We have the Quilcene Oyster Race Half marathon.

#### Staffing (next 30 days):

• I have no vacation planned for the month of September.

#### Significant Events and Service Delivery:

- C-Shift responded to an average of almost 3 incidents per day, totaling 29 incidents during the month of August! Notable incidents include:
- Mutual aid initial attack to the Beaver Valley Wildland Fire contained 3-acres and was threatening structures. Coordinated helicopter bucket drops, hose attacks, and mop-up with Forest Service and DNR. B21 was hired by DNR to return the next day to assist with containment line reinforcement and mop-up.
- Initial attack on a 6-acre fire at the end of Penny Creek Rd. Worked again with FS and DNR to contain fire. DNR Hired T21 to return the next day for water supply.
- Water usage report sent to PUD with approximately 30,000 gallons used mostly on wildland incidents.

- Continuing with EMS Skills and CEs.
- IV Log submitted to Colleen Rodrigues with a total of 30 sticks so far this year.
- FF/EMT Zak Torres is now a Red Carded FF and has been issued his certification.

- Completed AARs with EJFR for Beaver Valley Fire and a Brinnon Structure Fire.

#### Physical Resources and Quality of Life:

- Two wildland BK radios are malfunctioning and have been sent in for repair.
- PPE and Passport tags have been issued to Volunteer Oscar Levine.

#### Other:

 Started painting interior of crew quarters and approximately 50% complete at the time of this report. The priorities are painting the southwest bedroom and the kitchen before moving on to the rest of the house.
